the Northerly 22 feet of LA AMATISTA ROAD between Condesa Drive and the south line; the Easterly 23 feet of CONDESA DRIVE between La Amatista Road and the south line; and the Southerly 10 feet of 8TH STREET (Road Survey 1009) being also the Southerly 10 feet of the Northerly 60 feet of the Westerly 400 feet; all in the North 1/2 of the Southeast 1/4 of the Southeast 1/4 of Section 14, T14S, R4W, SBBM,

as more particularly referred to in Resolution of Intention

No. 199697 is unnecessary for present or prospective public street purposes.

BE IT FURTHER RESOLVED, that

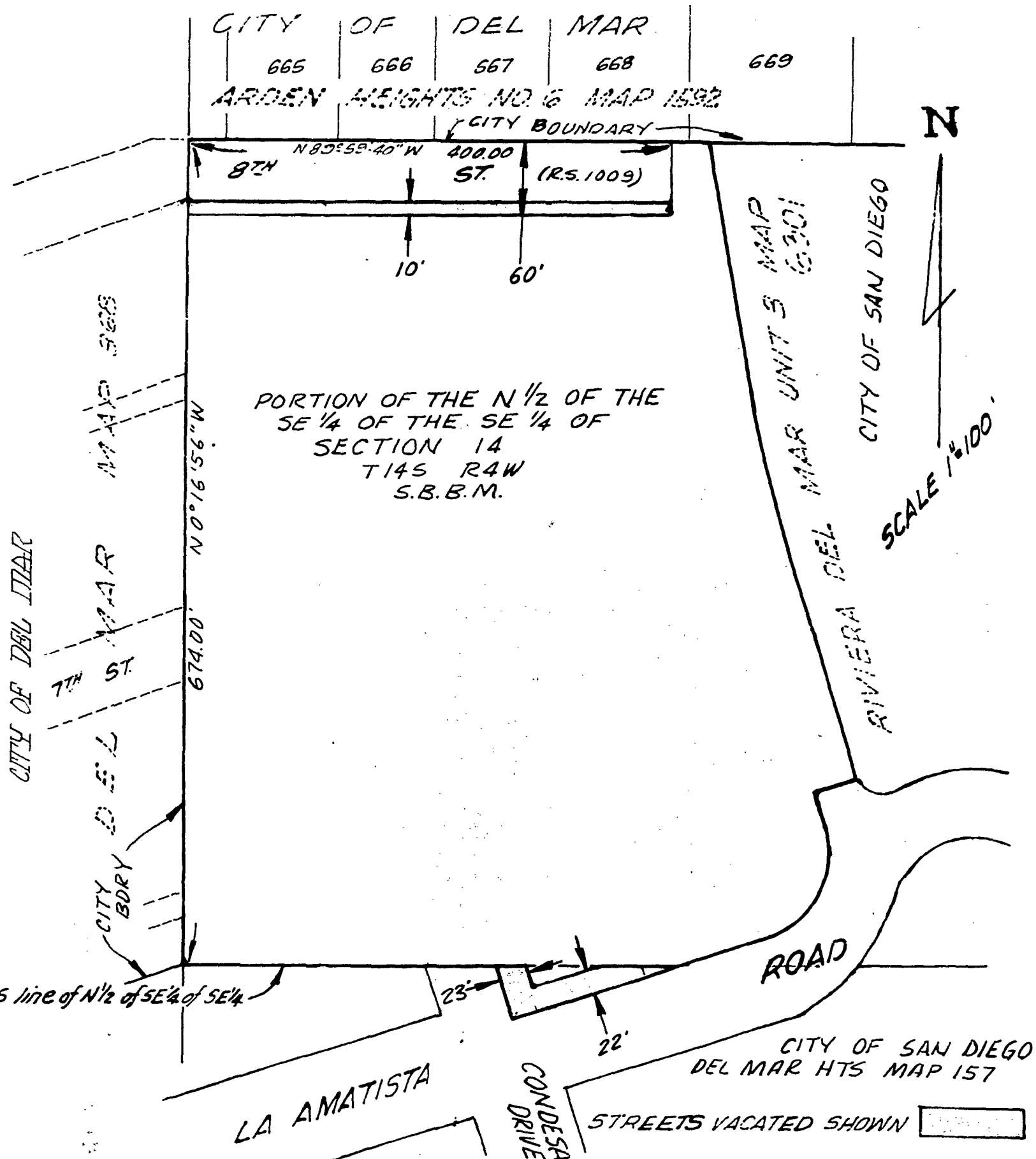
