

RESOLUTION NO. 199889

WHEREAS, PRINCESS PARK ESTATES, INC., by Richard E. Kasper, requested waiver of Section 102.0221 of the San Diego Municipal Code, which provision requires the undergrounding of privately-owned public utility systems within a subdivision; and

WHEREAS, certain privately-owned public utilities lying along the easterly boundary of Princess Del Sol Unit No. 12 and Princess Del Sol Unit No. 13 subdivisions are within limits of proposed Route 805 right of way; and

WHEREAS, the privately-owned public utility lines in question serve facilities which lie within the right of way of Route 75; and

WHEREAS, upon construction of the above-referenced freeways the privately-owned public utility lines and facilities served by said lines will be removed; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

The application of PRINCESS PARK ESTATES, INC., by Richard E. Kasper, for special permission to waive underground requirement for an existing overhead distribution line, located along the easterly boundary of Princess Del Sol Unit No. 12 and Princess Del Sol Unit No. 13, is granted, and the provisions of Section 102.0221 are hereby waived to the extent said provisions affect the line described herein.
