

RESOLUTION NO. 199890

WHEREAS, the Planning Commission of The City of San Diego has held a public hearing to consider the proposed Kearny Vista Community Plan, prepared by the Planning and Community Development Departments in cooperation with the citizens of the Kearny Vista area of the City; and

WHEREAS, the Kearny Vista Community Plan will serve as a guide for the development of an area comprising approximately 2800 acres of land bounded generally by Friars Road to the south, Interstate 5 to the west, Tecolote Canyon to the west and north, Artillery Drive to the north and Highway 395 to the east excluding the Capehart Housing between Genesee Avenue and Artillery Drive; and


WHEREAS, on April 22, 1970, the Planning Commission adopted and recommended for approval to the City Council the Kearny Vista Community Plan; and
