

# RESOLUTION No. 199893

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$272,985.00 by Raymond D. Haas, An Individual, for the CONSTRUCTION OF SAN YSIDRO COMMUNITY CENTER AND RENOVATION OF RECREATION CENTER BUILDING including ADDITIVE ALTERNATES 1 THRU 10 in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 731288.
2. That the expenditure of \$318,854.00 is hereby authorized out of the Capital Outlay Fund (245) of the City of San Diego solely and exclusively for the purpose of providing funds for the CONSTRUCTION OF SAN YSIDRO COMMUNITY CENTER AND RENOVATION OF RECREATION CENTER BUILDING including ADDITIVE ALTERNATES 1 THRU 10 in the City of San Diego, and related costs.
