**RESOLUTION No. 199927**

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be, and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with the STATE OF CALIFORNIA, DEPARTMENT OF PUBLIC WORKS, DIVISION OF HIGHWAYS for participation in the installation of traffic signals and safety lighting at the intersection of 19th Street and Imperial Avenue) in the City of San Diego, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 732154.

BE IT FURTHER RESOLVED, that the expenditure of \$12,000 is hereby authorized out of Gas Tax Fund 219 of The City of San Diego, solely and exclusively for the purpose of providing funds for the City's share in the traffic signals and safety lighting costs described above.


