

RESOLUTION NO. 199947

APPROVING MAP OF PRINCESS DEL SOL UNIT NO. 13 SUB-DIVISION AND ACCEPTING ON BEHALF OF THE PUBLIC THE PUBLIC STREETS DEDICATED ON SAID MAP, AND ACCEPTING ON BEHALF OF THE CITY OF SAN DIEGO THE ABUTTERS' RIGHTS OF ACCESS TOGETHER WITH THE EASEMENT AS GRANTED ON THIS MAP WITHIN THIS SUBDIVISION AND REJECTING THE OFFER OF DEDICATION FOR PUBLIC USE PARCELS A AND B MARKED "RESERVED FOR FUTURE STREET" AS SHOWN ON THIS MAP.

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

Said Council hereby finds that that certain map surveyed by ARTHUR B. SHURTLEFF, Registered Civil Engineer, and entitled, "PRINCESS DEL SOL UNIT NO. 13 Being a subdivision of a portion of Section 25, Township 18 South, Range 2 West, San Bernardino Meridian, in the City of San Diego, County of San Diego, State of California, according to official plat thereof.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the public streets, to wit: Del Sol Boulevard, Marcwade Drive, Layla Court, Layla Way and Marzo Street for public purposes, and said streets are hereby declared to be public streets and dedicated to the public use.

The said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, any and all abutters' rights of access in and to Del Sol Boulevard adjacent and contiguous to Lots 1205 to 1217 inclusive, all as granted and shown on said map.

The said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easement with the right of ingress and egress for the construction and maintenance of sewer and drainage facilities as granted and shown on said map and subject to the conditions set forth thereon.


The said Council rejects as a dedication for public street Parcels A and B of this subdivision marked "Reserved for Future Street" as shown on this map, under the provisions of Section 11616 of the Business and Professions Code.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public streets are accepted on behalf of the public as heretofore stated; and that those certain abutters' rights of access together with the easement with the right of ingress and egress for the construction and maintenance of sewer and drainage facilities are accepted on behalf of The City of San Diego, a municipal corporation, as above stated; and said Council has rejected on behalf of the public Parcels A and B marked "Reserved for Future Street" shown on this map within this subdivision, all as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
