

RESOLUTION NO. 199976

WHEREAS, Richard C. Levi, et al., on December 12, 1967, in the Superior Court of the State of California, in and for the County of San Diego, caused to be filed Action No. 304283 to quiet title to certain real property in a portion of El Camino Memorial Park, according to Map thereof No. 4719, filed February 20, 1961, in the office of the San Diego County Recorder; and

WHEREAS, there was dedicated on said Map No. 4719 for public use portions of El Camino Drive and Carroll Canyon Road; and

WHEREAS, the signers of the map for El Camino Memorial Park did not have fee title to said real property and therefore could not dedicate this land to the City; and

WHEREAS, the City Manager has recommended that the aforementioned action against The City of San Diego be settled by stipulated judgment; and

WHEREAS, said stipulated judgment will except an existing 20 foot road easement and the Road Survey No. 466 with a right of way width of 100 feet; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the City Attorney be, and he is hereby authorized and directed to sign a Stipulation in the case of Richard C. Levi, et al. v. El Camino Memorial Park, et al., Superior Court No. 304283, stipulating that judgment in said action may be entered quieting title in favor of the plaintiffs, but excepting an existing 20 foot road easement and the Road Survey No. 466 with a right of way width of 100 feet.
