Adopted on JUN 11 1970

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That Change Order No. 1, dated May 12, 1970, heretofore filed with the City Clerk of said City as Document No. 732238, issued in connection with the contract with Daley Corporation for the construction of traffic channelization improvements at various locations, said contract having been filed as Document No. 730070 in the office of said City Clerk, be and the same is hereby approved; and the changes therein set forth, amounting to an increase in the contract price of \$1,430.22 and an extension of time of 150 days extending the completion to July 5, 1970, be and the same are hereby approved.

BE IT FURTHER RESOLVED, that the Auditor and Comptroller is hereby authorized to transfer the sum of \$700 from Gas Tax Fund (219) and supplement Resolution No. 198324 in that amount, solely and exclusively for the purpose of providing funds for the contract changes described above.
