

RESOLUTION NO. 200007

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That Resolution No. 161025, adopted June 21, 1960, and Resolution No. 167376, adopted on August 24, 1961 by the Council of The City of San Diego, be and the same are hereby rescinded.

BE IT FURTHER RESOLVED, that the following schedule of fees for Mission Bay, recommended pursuant to Section 63.25.3(e) of the San Diego Municipal Code and approved by the City Manager, be and the same is hereby approved:

<u>Subject</u>	<u>Fee</u>	<u>Penalty</u>
a. Moorings in Mission Bay	\$2.40 per lineal boat foot per annum, but not less than \$30.00.	\$3.00 if not paid by February 1.
b. Mooring Installations	\$12.50	
c. Moving Mooring Installations	\$12.50	
d. Towing Derelicts Nonemergency Towing Within the Bay	\$3.00 for vessels under 16 feet; \$5.00 for vessels 16 feet and over.	
e. Impound Charges	\$2.00 per day.	
f. Pumping, Salvage and General:		
1) Barge and two men	1) \$25.00 first hour or part thereof, \$25.00 per hour thereafter.	1) and 2) Such rates shall be double between 5 PM and 8 AM.
2) Lighter Boat and one man	2) \$10.00 first hour or part thereof, \$10.00 per hour thereafter.	
g. Annual permit for tying up to Beach Mooring Bars	\$5.00	

BE IT FURTHER RESOLVED, that the City Manager may waive any of the fees contained in the schedule listed above arising out of the participation of any boat in a regularly scheduled regional or national race, meeting or other competitive event in Mission Bay.
