

RESOLUTION No. 200016


Adopted on JUN 16 1970

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$44,829.50 by Geo. Taylor Const. Co., A Partnership, for the CONSTRUCTION OF COLINA DEL SOL PARK AND RECREATION CENTER SHUFFLEBOARD COURTS AND CLUBHOUSE, including ADDITIVE ITEM "A" in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 731675.

2. That the expenditure of \$51,200.00 is hereby authorized out of the Bond Fund (725) and that the expenditure of \$7,000.00 is hereby authorized out of the Capital Outlay Fund (245) of the City of San Diego solely and exclusively for the purpose of providing funds for the CONSTRUCTION OF COLINA DEL SOL PARK AND RECREATION CENTER SHUFFLEBOARD COURTS AND CLUBHOUSE, including ADDITIVE ITEM "A" in the City of San Diego, and related costs.
