

RESOLUTION No. 200017

Adopted on JUN 16 1970

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the bids of Western Fastener Co., Gould Hardware & Machinery Company, Hansson Motor Supply, Inc., Western Metal Supply Co., and Southern Equipment and Supply Co. are hereby accepted and the City Manager is hereby authorized to execute contracts for the purchase of **HARDWARE, FASTENERS AND ROPE** as may be required for the period of one year beginning July 1, 1970 through June 30, 1971, per prices on file in the Purchasing Department, as follows:

1. Western Fastener Co., for Section I and Section III; terms 2%, 10th prox, plus sales tax, prices firm;
2. Gould Hardware & Machinery Company for Section II (Items 1 through 17, and Items 19 through 28), and Section VII, terms 2%, 30 days, plus sales tax, subject to escalation not to exceed 15% of bid prices;
3. Hansson Motor Supply, Inc., for Section IV, terms 2%, 10th prox, plus sales tax, subject to escalation not to exceed 5% of bid prices;
4. Western Metal Supply Co., for Section V; terms 2%, 30 days, plus sales tax, subject to escalation not to exceed 15% of bid prices;
5. Southern Equipment and Supply Co., for Section VI, terms 2%, 10th prox, plus sales tax; prices firm.
