That the plans and specifications for the furnishing of all labor, material, tools, equipment, transportation and other expense necessary or incidental for CONSTRUCTION OF CONDE STREET STORM DRAIN, 4TH AVENUE STORM DRAIN AND RECONSTRUCT INLETS IN MONROE AVENUE, San Diego, California

filed in the office of the City Clerk of The City of San Diego, California, on JUN 10 1970, and bearing official Document No. 732218, be, and the same are hereby approved.



BE IT FURTHER RESOLVED, that the Purchasing Agent of The City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.
