

RESOLUTION NO. 200031

WHEREAS, Resolution No. 195858, adopted January 23, 1969, authorized the Mayor and City Clerk to execute, for and on behalf of the City, a quitclaim deed conveying to the State of California, a corporation sovereign, portions of Blocks 426 and 436 of Old San Diego, Washington Park, within Old San Diego, and the underlying fee of City streets within the area designated as Old Town Project Area, as more particularly described in said deed, a copy of which is on file in the office of the City Clerk as Document No. 726803; and


WHEREAS, the deed did not meet with the approval of the United States Department of the Interior, which preferred separate conveyance of the portion of the property which was originally acquired from the Federal Government, perpetuating the deed provisions required under Federal Law and Regulations; and

WHEREAS, said Resolution No. 195858 should be rescinded and said deed cancelled; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That Resolution No. 195858, adopted by the Council of The City of San Diego on January 23, 1969, be, and the same is hereby rescinded, and that deed authorized to be executed thereby, a copy of which is on file in the office of the City Clerk as Document No. 726803, be, and it is hereby cancelled.
