

RESOLUTION NO. 200032

WHEREAS, heretofore The City of San Diego and the State of California entered into an agreement on March 3, 1967, which is on file in the office of the City Clerk as Document No. 709025, for the conveyance by City to State of all City-owned real property, including streets, within the Old Town Project area; and

WHEREAS, the terms and conditions of said conveyance are more particularly set forth in said agreement; and

WHEREAS, the State has now requested that the City quitclaim said City property within the Project Area to it in accordance with the provisions of said agreement; and

WHEREAS, City should now quitclaim said real property within the Project Area to State; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That that certain real property described in those forms of quitclaim deeds on file in the office of the City Clerk as Document No. 732269 and Document No. 732270, be and the same are hereby authorized to be conveyed to the STATE OF CALIFORNIA, a corporation sovereign.

2. That the Mayor and the City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, the following:

a. Quitclaim deed, the form of which is on file in the office of the City Clerk as Document No.


732269, quitclaiming to the STATE OF CALIFORNIA, a corporation sovereign, portions of Block 426 of Old San Diego, as more particularly described in said form of quitclaim deed.

b. Quitclaim deed, the form of which is on file in the office of the City Clerk as Document No.

732270, quitclaiming to the STATE OF CALIFORNIA, a corporation sovereign, portions of Block 436 of Old San Diego, Washington Park, within Old San Diego, and the underlying fee of City streets within the area designated as Old Town Project Area, as more particularly described in said form of quitclaim deed.

3. That the City Clerk of said City is hereby authorized and directed to deliver said deeds and a certified copy of this resolution to the Property Director for further handling.
