BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$30,731.00 by L. R. Hubbard, Jr., An Individual, for the CONSTRUCTION OF TWO TENNIS COURTS WITH LIGHTING SYSTEM, SCHEDULE II, AT ENCANTO PARK AND RECREATION CENTER AT 65TH STREET AND BROADWAY in the City of San Diego, California, is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 731824.

2. That the expenditure of \$39,300.00 is hereby authorized out of the Park and Recreation Bond Fund (725) of the City of San Diego solely and exclusively for the purpose of providing funds for the CONSTRUCTION OF TWO TENNIS COURTS WITH LIGHTING SYSTEM, SCHEDULE II, AT ENCANTO PARK AND RECREATION CENTER AT 65TH STREET AND BROADWAY in the City of San Diego, and related costs.
