BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$17,281.00 by Valley Crest Landscape, Inc., a Corporation, for the CROWN POINT SHORES - IRRIGATION AND LANDSCAPING - RIVIERA DRIVE - INGRAHAM STREET TO MOORLAND DRIVE in the City of San Diego, California is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 731575.

2. That the expenditure of \$22,000.00 is hereby authorized out of the Capital Outlay Fund (245) of the City of San Diego solely and exclusively for the purpose of providing funds for CROWN POINT SHORES - IRRIGATION AND LANDSCAPING - RIVIERA DRIVE - INGRAHAM STREET TO MOORLAND DRIVE in the City of San Diego, and related costs.





