

RESOLUTION No. 200047

Adopted on JUN 18 1970

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the bids of Graybar Electric, Pacific Wholesale Electric Co., and Consolidated Electrical Distributors are hereby accepted and the City Manager is hereby authorized to execute contracts for the purchase of **ELECTRICAL MAINTENANCE AND REPAIR MATERIALS** as may be required for the period of one year beginning June 1, 1970 through May 31, 1971, per prices on file in the Purchasing Department, as follows:

1. Graybar Electric for Section II; terms 2%, 15 days, plus sales tax; prices are firm;
2. Pacific Wholesale Electric Co. for Section III; terms 2%, 30 days, plus sales tax; subject to price escalation not to exceed 10% of bid prices;
3. Consolidated Electrical Distributors for Section IV; terms 2%, 10 days, plus sales tax; subject to price escalation not to exceed 10% of bid prices.
