

**RESOLUTION No. 200066**


Adopted on JUN 18 1970

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of NATIONAL RANCH CORPORATION, a corporation; HAYWARD LUMBER AND INVESTMENT CO., a corporation; TRES LOMAS, INC., a corporation; STEARNS ENGINEERING CO., a corporation; A. K. SPENCER; T. L. STEARNS also known as THEODORE L. STEARNS; WESTLANDS INVESTMENTS, INC., a corporation; ELLEN T. STEARNS; J. V. M. STEARNS; EVELYN STEARNS, executed in favor of The City of San Diego, bearing date March 20, 1970, conveying to said City an easement and right of way for street purposes through, over and across a portion of Quarter Section 77, Rancho de la Nacion, according to Map thereof No. 166, filed in the office of the County Recorder of San Diego County, May 11, 1869, as more particularly described in said deed, as certified by the Property Director, be, and the same is hereby approved; and the land therein conveyed is hereby set aside and dedicated as and for a public street and the same is hereby named PARADISE VALLEY ROAD.

That the City Clerk of said City is hereby authorized and directed to transmit the foregoing said deed to the Property Department for recording and further disposition.


