

# RESOLUTION No. 200069

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$93,055.50 by Roy C. Barnett, An Individual, for the DEVELOPMENT OF SOUTHCREST PARK AND RECREATION CENTER, including ADDITIVE ALTERNATE NO. 1 AND ADDITIVE ALTERNATE NO. 2 in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 731823.
  
2. That the expenditure of \$120,000.00 is hereby authorized out of the Capital Outlay Fund (245) of the City of San Diego solely and exclusively for the purpose of providing funds for the DEVELOPMENT OF SOUTHCREST PARK AND RECREATION CENTER, including ADDITIVE ALTERNATE NO. 1 AND ADDITIVE ALTERNATE NO. 2 in the City of San Diego, and related costs.
