WHEREAS, The City of San Diego is the owner of certain easements for drainage and sewer purposes affecting portions of Pueblo Lots 1181 and 1188, being also a portion of Fulton Heights Unit No. 7, according to Map thereof No. 5302, filed November 27, 1963, in the office of the San Diego County Recorder; and

That the Mayor and the City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf of, and as the act and deed of, The City of San Diego, a quitclaim deed, the form of which is on file in the office of the City Clerk as Document No. 732343, quitclaiming to THE OWNERS IN FEE SIMPLE OF RECORD of portions of Pueblo Lots 1181 and 1188, existing easements for drainage and sewer purposes affecting portions of Pueblo Lots 1181 and 1188, as more particularly described in said form of quitclaim deed.

BE IT FURTHER RESOLVED, that the City Clerk of said City be, and he is hereby authorized and directed to deliver said deed to the Property Director of said City for further handling.
