

RESOLUTION NO. 200119

WHEREAS, solid waste disposal is a very real and pressing problem in the City of San Diego; and

WHEREAS, ocean disposal of solid wastes presents a possible solution to this problem; and

WHEREAS, very little is presently known of possible detriments or benefits to be derived from ocean disposal of solid wastes; and

WHEREAS, The City of San Diego has requested the American Public Works Association to undertake a research project to determine possible effects of ocean disposal of solid wastes; and

WHEREAS, the American Public Works Association Research Foundation has agreed to undertake said research project; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the expenditure of \$9,000 be and is hereby authorized out of the Unallocated Reserve (Fund 100, Activity 53.30) solely and exclusively for the purpose of providing funds for The City of San Diego's share of a study to determine the effect of ocean disposal of solid wastes on the ecology of marine life as well as the economic feasibility of such disposal.
