BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the offer of Century Strand, Inc. is hereby authorized and the City Manager is hereby authorized to execute a contract for the purchase of furnishing and installing all necessary equipment to modify and improve the Stage Lighting Dimming System at the San Diego Civic Theater, for a total cost of \$6,864.00; terms 1%, 10 days, plus sales tax.
  
2. That the expenditure of \$7,500.00 is hereby authorized out of the Capital Outlay Fund 245 of the City of San Diego solely and exclusively for the purpose of providing funds for furnishing and installing all necessary equipment to modify and improve the Stage Lighting Dimming System at the San Diego Civic Theater, in the City of San Diego, and related costs.
