

RESOLUTION NO. 200148

WHEREAS, the State of California on June 9, 1970, in the Superior Court of the State of California, in and for the County of San Diego, caused to be filed Action No. 318818 to condemn certain real property in Lot 1 of City Highlands according to Map No. 5594, filed July 1, 1965 in the office of the County Recorder; parcel "A" of the City of San Diego Industrial Park Unit No. 1, according to Map No. 3978, filed October 1, 1958 in the office of the County Recorder; Lots 31 and 32 of the Highlands, according to Map No. 284, filed March 16, 1887 in the office of the County Recorder; parcel "B" and Lot 1 of the City of San Diego Industrial Park Unit No. 1, according to Map No. 3978, filed October 1, 1958 in the office of the County Recorder for freeway purposes; and

WHEREAS, the City Property Director has reviewed the appraisals of the subject property and has determined that the fair market value is Eight Hundred Fifty-Nine Thousand One Hundred Thirty-Eight Dollars (\$859,138.00); and


WHEREAS, the City Manager has recommended that the aforementioned action against the City of San Diego be settled by stipulated judgment; NOW THEREFORE,
