Mar Heights, Map No. 157,

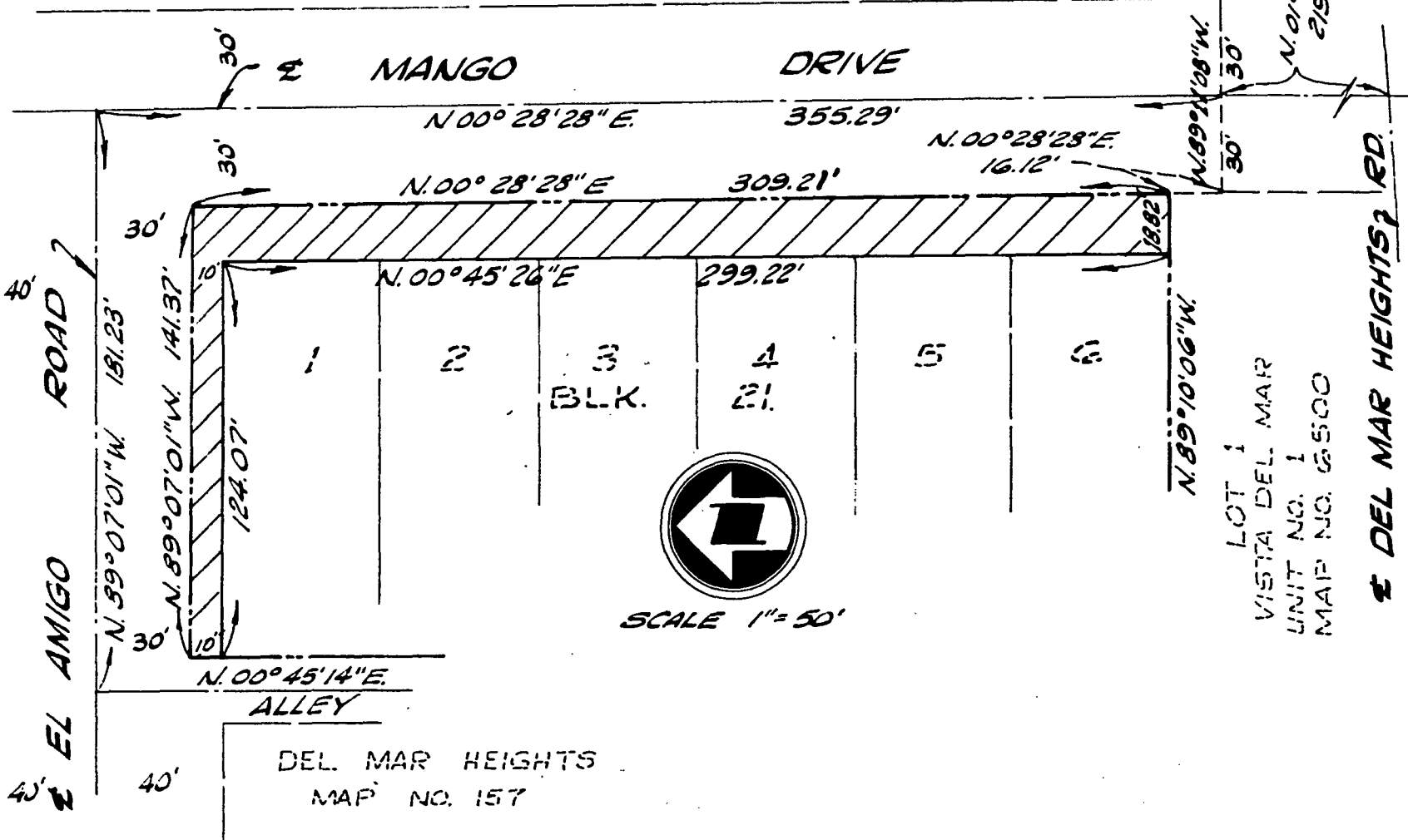
as more particularly shown on Map No. 12198-B, on file in the
