

RESOLUTION No. 200203

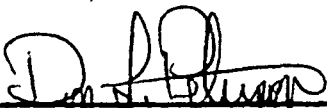
Adopted on JUL 7 1970

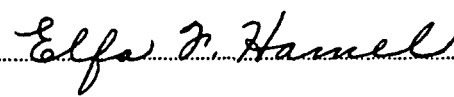
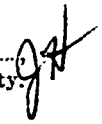
