

# RESOLUTION No. 200204

Adopted on JUL 7 1970

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the bids of (1) Stanley Andrews Sport Goods Co. (2) Crosthwaite Athletic Supply (3) Fournier Athletic Co., Inc. (4) Bill Smith Sporting Goods (5) Spartan Sports Supply are hereby accepted, and the City Manager is hereby authorized to execute contracts for the purchase of 45 items of MISCELLANEOUS ATHLETIC SUPPLIES for a period of one year beginning July 1, 1970 through June 30, 1971 per prices on file in the Purchasing Department as follows:

1. Stanley Andrews Sport Goods Co. for Items 6, 7, 12, 22, 28, 33, and 34; terms 2% 30 days plus sales tax, subject to escalation not to exceed 5% of bid prices;
2. Crosthwaite Athletic Supply for Items 3, 11, 18, 30, 31, and 45; terms 2% 30 days plus sales tax, subject to escalation not to exceed 10% of bid prices;
3. Fournier Athletic Co., Inc. for Items 1, 16, 20, 21, 27, 35, 36, and 38; terms 2% 30 days plus sales tax, prices are firm;
4. Bill Smith Sporting Goods for Items 4, 5, 8, 9, 10, 13, 14, 15, 23, 29, 32, 37, 41, 42, 43, and 44; terms 2% 30 days plus sales tax, prices are firm;
5. Spartan Sports Supply for Items 2, 17, 19, 24, 25, 26, 39, and 40; terms net 30 days plus sales tax, subject to escalation not to exceed 5% of bid prices.
