PUBLIC STREET DEDICATED ON SAID MAP WITHIN THIS
SUBDIVISION.


BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed
by DON NASLAND, Licensed Land Surveyor, and entitled, "ROTO
AIRE PROPERTIES SUBDIVISION Being a subdivision of portions
of Lots 46, 47, 48, and 52, all of Lots 49, 50 and 51, together
with a portion of Naples Street as vacated and closed to public
use, all in Boulevard Gardens, in the City of San Diego, County
of San Diego, State of California, according to Map thereof
No. 1505, filed in the office of the County Recorder of San
Diego County, December 11, 1912.", is made in the manner and
form prescribed by law and conforms to the surrounding surveys;
that said map and the subdivision of land shown thereon is hereby
approved and accepted; and said Council hereby accepts on behalf
of the public, portion of Knoxville Street, for public purposes,
and said portion of street is hereby declared to be portion of
public street and dedicated to the public use.

The Clerk of said City is hereby authorized and directed
to endorse upon said map, as and for the act of the Council,
that said Council has approved said subdivision map and that
said portion of public street is accepted on behalf of the pub-
lic as heretofore stated.

Said City Clerk is hereby directed to transmit said map to
the Clerk of the Board of Supervisors of the County of San Diego,
California.
