BE IT RESOLVED, by the Council of The City of San Diego, as follows:

Said Council hereby finds that that certain map surveyed by CHARLES W. CHRISTENSEN, Registered Civil Engineer, and entitled, "WEST BERNARDO VILLAGE UNIT NO. 3 Being a subdivision of a portion of Rancho San Bernardo, in the City of San Diego, County of San Diego, State of California, according to Map thereof, recorded August 21, 1883, in Book 2, Page 462 of Patents.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, portions of public streets, to wit: portion of West Bernardo Drive and portion of Duenda Road for public purposes and said portions of streets are hereby declared to be portions of public streets and dedicated to the public use.
