BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the expenditure of \$3,900 is hereby authorized from Gas Tax Fund 219 of The City of San Diego, solely and exclusively for the purpose of modification of traffic signals at 70th Street and El Cajon Boulevard, modification of traffic signals at Balboa Avenue and Genesee Avenue, and the installation of new street light luminaires at Fordham Street and Sports Arena Boulevard in the City of San Diego.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized and empowered to do by City forces the necessary work for the above described modification of traffic signals and installation of street light luminaires, pursuant to recommendation of the City Manager and submission of estimates by him indicating that said work can be done by the City forces more economically than if let by contract.
