

WHEREAS, Mrs. Helen L. Mooney has by affidavit on May 18, 1970, stated that she clipped coupons No. 18 from five (5) City of San Diego Harbor Improvement 3-1/2% Bonds due 1980; and

WHEREAS, Mrs. Helen L. Mooney has by said affidavit stated that the clipped coupons from bonds Nos. 2591, 2592, 2593, 2594 and 2595 were inadvertently destroyed between April 15, 1970 and May 1, 1970; and

WHEREAS, there is no cost to issue new coupons; and

WHEREAS, Section 53460 et seq. of the California Government Code permits a city to issue new coupons to replace lost or destroyed coupons; and

WHEREAS, Mrs. Helen L. Mooney has provided a Bond for Securities Lost or Destroyed No. 8420475, issued by the Fidelity and Deposit Company of Maryland, holding the City harmless in the amount of \$87.50, the value of the lost coupons; and

WHEREAS, the Council of The City of San Diego is satisfied that five (5) No. 18 coupons from City of San Diego Harbor Improvement 3-1/2% Bonds Nos. 2591, 2592, 2593, 2594 and 2595 were lost or destroyed; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the City Treasurer is authorized to issue five (5) new No. 18 coupons dated May 1, 1970 at \$17.50 each to replace those lost or destroyed by Mrs. Helen L. Mooney.

That the City Treasurer place in his files the affidavit of Mrs. Helen L. Mooney and the Bond for Securities Lost or Destroyed written by Fidelity and Deposit Company of Maryland.
