

BE IT RESOLVED, by the Council of The City of San Diego,  
as follows:

That an easement for the purpose of a right of way for  
a public street (roadway) and incidents thereto, through, over,  
under, along and across the hereinafter described property be,  
and the same is hereby set aside and dedicated as and for  
a public street and the same is hereby named PARK RIDGE  
BOULEVARD:

An easement for right of way for a public  
street and incidents thereto, through, over,  
under, upon, along and across that portion  
of Lot 70, Rancho Mission, more particularly  
described as follows:

Beginning at the northwest corner of  
Vista Del Cerro Unit No. 1 as shown on  
Map No. 6239, said point lying on the  
extension of the southwest line of  
Lot 41 of said Vista Del Cerro Unit No. 1  
and said point being on the arc of an  
800.00 foot radius curve, a radial to  
said point bears North 66°03'04" West;  
thence North 467.83 feet along the  
arc of last said curve through a central  
angle of 33°30'20"; thence radially to  
last said curve North 32°32'44" West,  
30.00 feet to an 830.00 foot radius curve  
concentric with previously said curve;  
thence South 485.37 feet along the arc  
of last said curve through a central  
angle of 33°30'20"; thence South 66°03'04"  
East to the point of beginning.

BE IT FURTHER RESOLVED, that the City Clerk is hereby  
directed to file a certified copy of this resolution in  
the office of the County Recorder of San Diego County.
