BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That an easement for the purpose of a right of way for a public street (roadway) and incidents thereto, through, over, under, along and across the hereinafter described property be, and the same is hereby set aside and dedicated as and for a public street and the same is hereby named MARGERUM AVENUE:

All that portion of Lot E of a portion of Lot 70 of Rancho Mission of San Diego, in the City of San Diego, County of San Diego, State of California, according to Referee's Partition Map thereof made in an action entitled "San Diego Realty Company, a corporation v. Maria Y Olvera, et al." on file in the office of the County Clerk of said County in Civil Case No. 15191, described as follows:

A strip 84 feet wide being 42 feet each side measured at right angles or radial from the following described center line:

Beginning at the Northerly end of the center line of Margerum Avenue as shown on Hill 'N Dale Unit No. 1, being in The City of San Diego, County of San Diego, State of California, according to Map thereof No. 6452 filed in the office of the Recorder of said County, said center line bears North 41°09°01" West to said point; thence continuing North 41°09'01" West 40.10 feet to the beginning of a tangent 1000 foot radius curve concave Easterly; thence Northerly along said curve through an angle of 12°41'37" a distance of 221.54 feet; thence tangent to said curve North 28°27'25" West 184.22 feet to the beginning of a tangent 1500 foot radius curve concave Westerly; thence Northerly along said curve through an angle of 3°57'41" a distance of 103.71 feet to a point of inter-section with the center line of Road Survey No. 627, a plat of which is on file in the office of the County Engineer of said County; said point of intersection being the terminus of this center line description. The Easterly and Westerly side lines of said 84 foot wide strip shall be prolonged or shortened to terminate in said center line of said road survey which bears North 24°29'13" East through said point of intersection.

BE IT FURTHER RESOLVED, that the City Clerk is hereby directed to file a certified copy of this resolution in the office of the County Recorder of San Diego County.
