certain legal description in Document No. 732262
on file with the Clerk of the City.
2. That "Prime Agricultural Land," as that term is
defined in Section 51201 (c) of the California Government
Code, is contained within the proposed Agricultural Preserve.
3. That the highest and best use of the land within
the proposed Agricultural Preserve is for agricultural and
compatible uses as defined in the California Land Conservation
Act of 1965.
4. That the San Pasqual - Lake Hodges area in the City
of San Diego as specifically delineated on Document No.
732261 , and as set out in that legal

description in Document No. 732262, on file in the office of the Clerk of the City is hereby designated to be the San Pasqual Valley Agricultural Preserve pursuant to the California Land Conservation Act of 1965.
