

RESOLUTION NO. 200256

WHEREAS, on March 12, 1970, the City Council passed Resolution No. 199250 authorizing the City Manager to prepare and submit the appropriate application forms to the Secretary of the Department of Commerce for the purpose of receiving a \$35,650 technical assistance grant from the Economic Development Administration for the planning and coordination of a 1970 Youth Opportunity Program in San Diego; and

WHEREAS, the City Manager filed the above-described application with the Secretary of the Department of Commerce and has been informed that money was not available for expansion of programs; and

WHEREAS, the City Manager has received a grant offer of \$20,000 from said Secretary; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the City Manager is hereby authorized to accept the grant offer of \$20,000 from the Economic Development Administration for the 1970 Youth Opportunity Program.

BE IT FURTHER RESOLVED, that the City Council authorizes the City Auditor and Comptroller to transfer the sum of \$7,500 from the General Fund Unallocated Reserve to the Youth Opportunity Grant Fund 287 for interim financing of the 1970 program, such sums to be returned to the General Fund upon receipt of the final 1970 grant payment.
