WHEREAS, the County of San Diego, California State Division of Highways, San Diego Unified Port District, The City of San Diego and 12 other incorporated cities in San Diego County have joined together in a joint powers agreement to undertake comprehensive planning studies needed by all of said agencies under the auspices of the San Diego County Comprehensive Planning Organization; and

WHEREAS, the Budget and Programs Committee has prepared a Member Agency Support Budget for Fiscal Year 1970-1971; and


WHEREAS, the Technical Committee, the Management Committee and the Policy Committee of the San Diego County Comprehensive Planning Organization have recommended approval of said Member Agency Support Budget; and

WHEREAS, The City of San Diego's allocation of in-kind staff services to be provided is estimated at a value of \$51,800, an amount which review has indicated is equitable and appropriate; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That The City of San Diego provide in-kind staff services in the amount of \$51,800 to the San Diego County Comprehensive Planning Organization Member Agency Support Budget for Fiscal Year 1970-1971, and that the City Clerk is hereby directed to file this resolution with the County Board of Supervisors.
