BE IT RESOLVED, by the Council of The City of San Diego, as follows:

Said Council hereby finds that that certain map surveyed by RAYMOND F. HALL, JR., Registered Civil Engineer, and entitled, "VALLEY MEADOWS Being a subdivision of a portion of Lot 65 of the Rancho Mission, in the City of San Diego, County of San Diego, State of California, according to Partition Map thereof on file in the office of the County Clerk of San Diego County, in Action No. 348 of the Superior Court of the State of California, in and for the County of San Diego, entitled 'Juan M. Luco et al. vs. The Commercial Bank of San Diego et al. '", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the portion of public street, to wit: portion of Mission Gorge Road for public purposes and said portion of street is hereby declared to be portion of public street and dedicated to the public use.
