2. That the expenditure of \$222,500.00 is hereby authorized out of the Sewer Bond Fund (728) of the City of San Diego solely and exclusively for the purpose of providing funds for the CONSTRUCTION OF GRAPE AND GROVE STREETS SEWER REPLACEMENT in the City of San Diego, and related costs.
