That the Mayor and the City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf of, and as the acts and deeds of, The City of San Diego, quitclaim deeds, the forms of which are on file in the office of the City Clerk as Document No. 732694, and Document No. 732695, quitclaiming to Avco Community Developers, a California corporation, two easements for sewer purposes affecting a portion of Pueblo Lot 1103, as more particularly described in said form of quitclaim deed.

BE IT FURTHER RESOLVED, that the City Clerk of said City be, and he is hereby authorized and directed to deliver said deed to the Property Director of said City for further handling.
