That the expenditure of \$270,000 is hereby authorized out of Capital Outlay Fund 245 of The City of San Diego, solely and exclusively for the purpose of providing funds for the reimbursement of the General Fund on a monthly basis for engineering costs incurred in Capital Improvement projects, including 1911 Acts, supplementing Resolution No. 185091 dated September 30, 1965 for this purpose.
