

RESOLUTION NO. 200361

A RESOLUTION DETERMINING THAT THE PUBLIC INTEREST AND NECESSITY DEMAND THE ACQUISITION, CONSTRUCTION OR COMPLETION OF CERTAIN MUNICIPAL IMPROVEMENTS AND MAKING FINDINGS RELATING THERETO.

IT IS HEREBY RESOLVED, DETERMINED AND ORDERED, by the Council of The City of San Diego, as follows:

Section 1. The public interest and necessity demand the acquisition, construction or completion of a certain improvement, to wit: to improve and develop that certain area in the San Pasqual Valley known as the San Diego Wild Animal Park, and to expand the facilities therein to provide recreational, educational, scientific, ecological and research facilities in harmony with the open space concept of the Valley. The estimated cost of this municipal improvement is the sum of Six Million Dollars (\$6,000,000).

Section 2. The cost of the foregoing municipal improvement and the principal amount of the bonded indebtedness proposed to be incurred shall and will be too great to be paid out of the ordinary annual income and revenue of the City and will require an expenditure greater than the amount provided by the annual tax levy.

Section 3. This municipal improvement is necessary and convenient to carry out the objects, purposes and powers of The City of San Diego.

Section 4. This Council intends to submit to the qualified voters of the City at a special municipal bond election to be held in the City on November 3, 1970, and to be consolidated with the State-wide General Election to be held on the same date, one (1) proposition for the issuance of general

obligation bonds of the City, all of such bond issue being in the principal amount of the estimated cost of the municipal improvement, as set forth in this resolution.
