BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That an easement for the purpose of a right of way for a public street (roadway) and incidents thereto, through, over, under, along and across the hereinafter described property be, and the same is hereby set aside and dedicated as and for a public street and the same is hereby named ILEX AVENUE:

All that portion of Lot 1, Imperial Manor Unit No. 1, according to Map thereof No. 6391, filed on the 13th of June 1969 in the office of the Recorder of the County of San Diego, further described as follows:

Commencing at the Northeasterly corner of said Map No. 6391; thence South 00°36'03" West, a distance of 30.00 feet to the TRUE POINT OF BEGINNING and to an intersection with the Southerly boundary of that certain 30.00 foot strip of land, dedicated for Ilex Avenue, on said Map No. 6391; thence North 89°20'47" West, along said Southerly boundary, a distance of 618.54 feet to the beginning of a tangent 20.00 foot radius curve, concave Southeasterly; thence Southwesterly along the arc of said curve through a central angle of 90°00'37", an arc length of 31.42 feet; thence tangent to said curve, South 00°38'34" West, a distance of 5.00 feet to a point of cusp and being the beginning of a 20.00 foot radius curve, concave Southeasterly; thence Northeasterly along the arc of said curve through a central angle of 90°00'37", an arc length of 31.42 feet to the beginning of a tangent line drawn parallel with and distant 5.00 feet Southerly, measured at right angles from said Southerly line of Ilex Street; thence South 89°20'47" East along said parallel line, a distance of 618.54 feet to the Easterly line of said Map No. 6391; thence North 00°36'03" East along said Easterly line, a distance of 5.00 feet returning to said TRUE POINT OF BEGINNING.
