

RESOLUTION NO. 200371 JUL 23 1970

WHEREAS, Penasquitos, Inc., subdivider of Penasquitos View Unit No. 3, Penasquitos Town Center and Carmel Penasquitos Plaza filed tentative subdivision maps on February 17, 1970, March 2, 1970 and February 16, 1970, respectively; and

WHEREAS, Ordinance No. 10239 (New Series), adopted February 19, 1970, provides that its provisions will be applicable to all tentative maps filed with The City of San Diego after April 16, 1970; and

WHEREAS, on July 23, 1970 Penasquitos, Inc. requested permission of the City Council to file with The City of San Diego new tentative subdivision maps to supersede for all purposes T.M. 70-54, T.M. 70-66 and T.M. 70-53 covering all that land encompassed by T.M. 70-54, T.M. 70-66 and T.M. 70-53 heretofore filed; and


WHEREAS, Penasquitos, Inc. acknowledged that it was aware that the grant of permission requested would result in the application of Ordinance No. 10239 (New Series) to the new tentative subdivision maps and result in the subdivider being required to pay substantial fees for the purposes outlined in Ordinance No. 10239 (New Series); NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. Penasquitos, Inc. is granted permission to file tentative subdivision maps which will supersede for all purposes T.M. 70-54, T.M. 70-66 and T.M. 70-53 heretofore filed on February 17, 1970, March 2, 1970 and February 16, 1970, respectively and the filing date for the new tentative maps will be July 23, 1970.

2. The usual fee for filing a tentative subdivision map is hereby waived as to the new tentative maps.
