

RESOLUTION No. 200382


Adopted on JUL 28 1970

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of SECTRAS CORPORATION, a California corporation, executed in favor of The City of San Diego, bearing date July 17, 1970, conveying to said City those portions of the easterly one-half of Second Avenue and the northerly one-half of "B" Street adjoining Lots A through F of Block 12 of Horton's Addition, in the City of San Diego, County of San Diego, State of California according to map thereof made by L. L. Lockling on file in the office of the County Recorder of San Diego County, as more particularly described in said deed, as certified by the Property Director, be, and the same is hereby approved.


