as more particularly referred to in Resolution of Intention No. 200089 is unnecessary for present or prospective public street purposes.

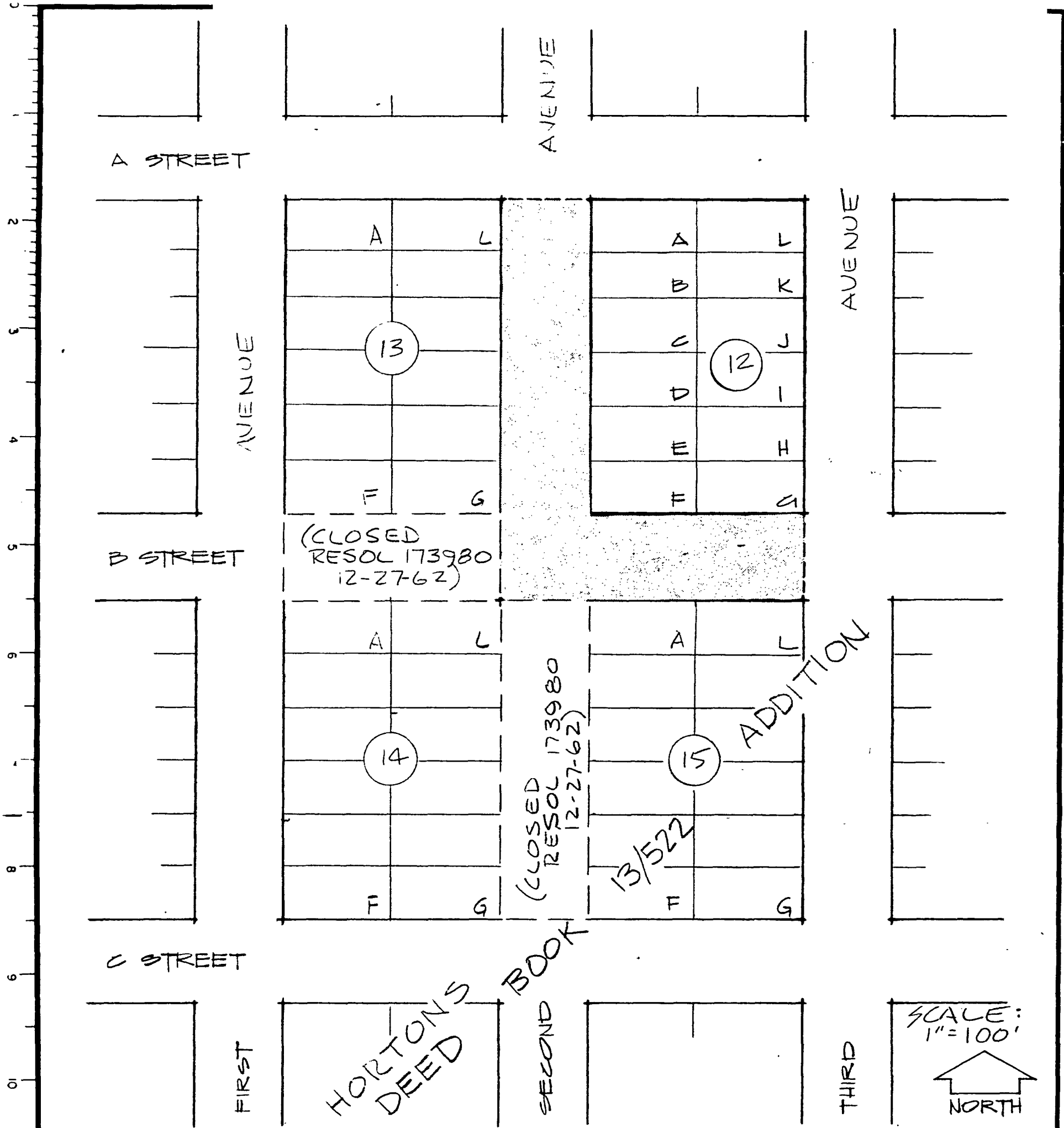
BE IT FURTHER RESOLVED, that B STREET between Second Avenue and Third Avenue, and SECOND AVENUE between A Street and B Street,
