Co. for the CONSTRUCTION OF THE CADMAN PARK BUILDING INCLUDING ADDITIVE ALTERNATES 1 THRU 3 in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 731957.

2.
