and the same is hereby ordered vacated.

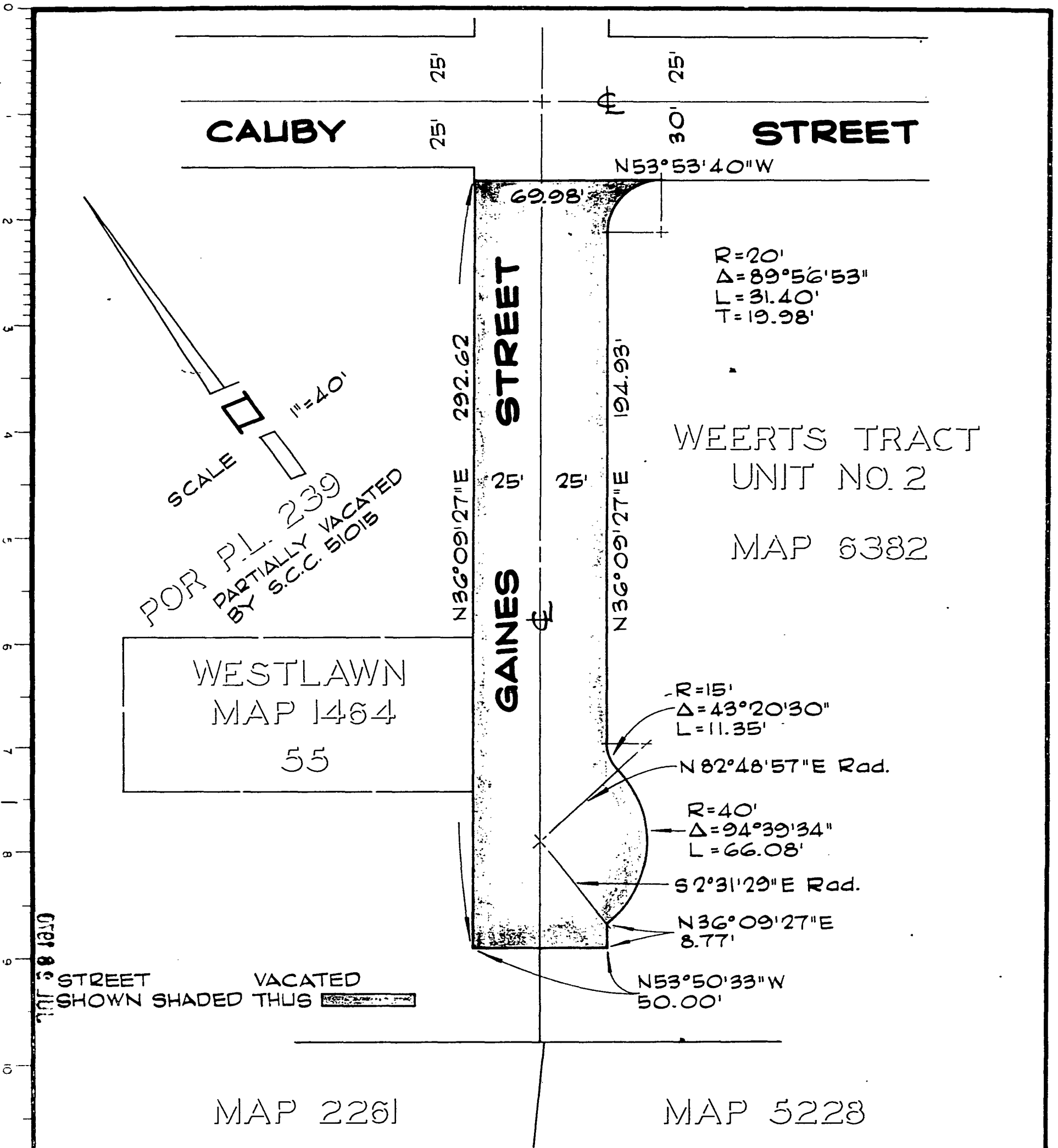
BE IT FURTHER RESOLVED, that the City Clerk shall cause a
