APPROVING MAP OF PENASQUITOS VILLAS UNIT NO. 1  
SUBDIVISION AND ACCEPTING ON BEHALF OF THE PUBLIC  
THE PUBLIC STREETS AND THE ALLEYS DEDICATED ON SAID  
MAP, AND ACCEPTING ON BEHALF OF THE CITY OF SAN  
DIEGO THE ABUTTERS' RIGHTS OF ACCESS AS GRANTED  
ON THIS MAP WITHIN THIS SUBDIVISION.

BE IT RESOLVED, by the Council of The City of San Diego,  
as follows:

Said Council hereby finds that that certain map surveyed  
by WILLIAM B. RICK, Registered Civil Engineer, and entitled,  
"PENASQUITOS VILLAS UNIT NO. 1 Being a subdivision of a portion  
of Rancho los Penasquitos, in the City of San Diego, County of  
San Diego, State of California, according to the Map accompanying  
the patent to said Rancho recorded in the office of County  
Recorder of San Diego County, in Book 2, Page 385 of Patents.",  
is made in the manner and form prescribed by law and conforms to  
the surrounding surveys; that said map and the subdivision of land  
shown thereon is hereby approved and accepted; and said Council  
hereby accepts on behalf of the public, the public streets, to  
wit: Carmel Mountain Road, Via San Marco, Via Rimini and the  
alleys for public purposes and said streets and the alleys are hereby  
declared to be public streets and alleys and dedicated to the public  
use.

BE IT FURTHER RESOLVED, that the said Council accepts on  
behalf of The City of San Diego, a municipal corporation, any and  
all abutters' rights of access in and to Carmel Mountain Road,  
adjacent and contiguous to Lots 8, 9, 10, 11, 12, 13 and 14, all  
as granted and shown on said map.

The Clerk of said City is hereby authorized and directed to  
endorse upon said map, as and for the act of the Council that  
said Council has approved said subdivision map and that said public

streets and the alleys are accepted on behalf of the public as heretofore stated; and that those certain abutters' rights of access, as granted and shown on this map within this subdivision, are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
