

**RESOLUTION No. 200467**


Adopted on AUG 4 1970

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of JOSEPH J. WADE, a widower, executed in favor of The City of San Diego, bearing date June 8, 1970, conveying to said City Lots 7 and 8 of Block 7, Paradise Valley Heights, being a subdivision of the Northwest Quarter of Quarter Section 77 of Rancho de la Nacion, according to Map No. 166 on file in the office of the County Recorder, as shown on Partition Map thereof, filed in the office of the County Clerk of San Diego County, in an action entitled "Union Trust Company of San Diego, a corporation v. Louis J. Beach, et al.," as more particularly described in said deed, as certified by the Property Director, be, and the same is hereby approved; and the land therein conveyed as Parcel 1 is hereby dedicated as and for a public street and the same is hereby named PARADISE VALLEY ROAD.

That the City Clerk of said City is hereby authorized and directed to transmit the foregoing said deed to the Property Department for recording and further disposition.


