
Pursuant to authority conferred by and in accordance with the provisions of Section 21102 of the California Vehicle Code, a temporary closing to vehicular traffic between the hours of 8:30 a.m. and 3:30 p.m. on Mondays through Fridays (excluding holidays), be and the same is hereby established on the following street in said City:

BEARDSLEY STREET between the south side of the alley south of Julian Avenue and the north side of Kearney Avenue.

BE IT FURTHER RESOLVED, that Our Lady of Guadalupe School, 744 Beardsley Street, shall be responsible for the purchase and maintenance of necessary barricades, the erection and removal of said barricades, which shall be removed daily at 3:30 p.m. Mondays through Fridays, and for the supervision of said area when temporarily closed; and

BE IT FURTHER RESOLVED, that the above resolution shall not be effective until appropriate signs giving notice thereof are posted along the street affected.
