

RESOLUTION No. 200489


Adopted on AUG 11 1970

1. That the bid of \$197,473.50 by Henson Construction Inc., A Corporation, for the PARADISE HILLS OUTFALL SEWER in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 731912.

2. That the expenditure of \$230,000.00 is hereby authorized out of the Sewer Revenue Fund (506) of the City of San Diego solely and exclusively for the purpose of providing funds for the PARADISE HILLS OUTFALL SEWER in the City of San Diego, and related costs.




